All students and a Parent/Guardian are required to complete this form together to enroll in our 1:1 Chromebook Initiative. The form is to be filled out for every student within a family receiving a Chromebook. Completion of this form will acknowledge you have read our technology policies and 1:1 Chromebook Initiative Agreement.

Please read the Technology Acceptable Use Policy (AUP) and Responsible Use Guidelines Chromebooks distributed to students in our 1:1 program are property of the Quincy Public Schools (QPS). These Chromebooks must be treated with care and kept safe from abuse, accidental damage, and theft. You also agree to the terms and the policies within the QPS Student Handbook, including the Acceptance Use Policy, and accept responsibility for the district-owned Chromebook.

I/we understand that Chromebook use is a privilege, not a right.

I/we understand that I am expected to bring the Chromebook to school every day with a fully charged battery.

I/we understand and accept that the QPS is solely responsible for maintenance of the Chromebook. I will report any problems with my QPS-issued Chromebook to a teacher, administrator, or QPS I.T. staff. I will not attempt to maintain, update, upgrade, or repair the Chromebook.

I/we understand that the Chromebook is my responsibility and that damage or loss of the Chromebook, charger, or both as a result of improper use could result in disciplinary action, fees, or both at the discretion of the administration. Chromebook malfunctions, failures, and accidental damage, encountered through normal use will not incur a fee. Intentional or reckless misuse may result in disciplinary action, fees, or both.

I/we understand that the Loss and theft of Chromebooks and chargers will incur the following fees. This fee structure is the same procedure applied to any lost or stolen school-owned equipment like books where a student obligation will be assigned to collect fees.

I/we will not write on the Chromebook, affix any decals, or permanently alter its physical appearance.

I/We understand that a protective case is highly recommended to prevent physical damage.

I/we will report inappropriate use to a teacher, administrator, or QPS I.T. staff immediately.

I/we will return the Chromebook if requested by QPS personnel or upon withdrawing from the school.

I/we agree to forever release QPS and all employees, agents, board members, volunteers, and all individuals or organizations assisting or participating in any voluntary or educational programs of the Town from all claims, rights or causes of actions that may arise, directly or indirectly, from personal injuries to myself or property damages resulting from my participation in this QPS 1:1 Chromebook program.

By signing this Agreement, students and parents/guardians agree to abide by this Agreement and QPS policies as outlined in the Student Handbooks and Acceptable Use Policy.
